Since the 2008-2009 school year, our district has exceeded the FCC standard of 100 Mbps per 1000 students. During that time frame, we upgraded all edge and core switch equipment. The result of these upgrades included; 1 Gb minimum speed to every wired network drop, Power over Ethernet, and upgraded 1 Gb connectivity between our three buildings.

In our High School, we established a 10 Gb backbone between all wiring closets in the facility. At our Middle and Elementary buildings, backbone speeds were upgraded to 1 Gb. We also have a 1Gb connection to the internet via Erie 1 BOCES/WNYRIC. We plan to further upgrade our network speeds in the coming year to establish a 10Gb backbone throughout all of our facilities.

In 2013, as we embarked upon another capital facilities project., we brought our focus to the wireless networking aspect of our technology portfolio. During this effort, we installed two (2) Category 6A wires into every classroom in the district – and multiple wires to group areas (libraries, cafeterias, auditoriums, etc.). Our analysis of this project, as part of our technology instruction efforts, indicated that an access point per classroom provided a much more robust and bandwidth intensive solution for the burgeoning device market.

Today, every instructional room in our district is wired and ready for wireless networking equipment to support our instructional vision. Additionally, this wiring, when fully leveraged, will connect the wireless network to a very capable and stable wired infrastructure. It is important to note that this wiring is terminated, tested and ready to attach to switches capable of furnishing POE+ with 802.11 ac revision 2 access points as detailed in this request.

Our SSIP is designed to assist with the purchase of necessary equipment to create a robust wireless infrastructure that is universally available throughout all three of our instructional buildings. This equipment will include wireless access points, controllers, edge switches and a core switch sized to accommodate the expected proliferation of devices that will be enabled by this wireless infrastructure. We intend to deploy a wireless access point to each classroom and multiple access points in "group" areas such as libraries and cafeterias. By installing an access point per classroom, we expect a reliable and high speed connectivity to be established for all students and devices that may be utilized in the classroom setting.

Our vision for these technologies is multifaceted; we envision implementation of technology which, from a student perspective, will enhance their ability to communicate with their teachers and fellow students, organize their work into meaningful contexts with an eye toward portfolio creation, and a means to transcend the confines of the school day and school building.

From the perspective of a faculty member, we envision a means by which teachers can, in nearly real time, see evidence of learning from their students both within the classroom and after hours. Such "instantaneous" feedback related to student understanding can inform the instructional practice and provide an indication to the teacher that some differentiation of the material may be required for specific students.

Finally, the collaborative models that will be afforded by these technologies can create opportunities for teachers to "flip" the classroom, further enhancing instruction and further solidifying the feedback loops necessary to determine the effectiveness of a lesson for each individual student.

To empower this vision, we plan to broaden the availability of wireless access to all buildings and grade levels. Institute BYOD for (at least) High School students. Explore opportunities for one-to-one technology deployment at lower grade levels. Introduce a "portal" for student access via either program to aggregate interfaces to various resources in which the district has subscribed, a single location for all student data storage capacity, and a means by which teachers can present relevant electronic resources and assignments to their students on a class by class basis.

Any device deployment model (one-to-one, class sets of devices, BYOD) will require both higher bandwidth and increased saturation of wireless access points across all of our instructional buildings. We've begun with the premise that class size increases may result in up to thirty (30) devices per classroom seeking network connectivity. To accommodate these, as described previously, we wired every classroom and group area throughout the district to accommodate an access point per classroom AND multiple access points in group areas (libraries, cafeterias, gymnasiums, etc.). Our research on current technologies available led us to seek acquisition of an 802.11 AC (Revision 2) wireless network controller and 300 access points to deliver adequate access and bandwidth. To support access points, we utilized category 6A Ethernet wiring to each end point. This application details the addition of a POE+ switch in each wiring closet to deliver power and 1 Gb data connectivity. We also seek an upgrade to our core network switch in anticipation of a increases in the total number of devices requiring support.
